



Environmental, Health, and Safety Information

We ask that you adhere to the following Environmental, Health, and Safety policies, rules, and practices to ensure compliance to local, state, and federal environmental, health, and safety regulations while in this facility.

Authorization by a Precision Resource representative is required before you perform work in our facility.

Visitor Registration

All visitors to Precision Resource must sign in using the visitor register or monitor and must not leave the lobby without an escort.

Security

Visitors must be accompanied by a Precision Resource employee while in the building or anywhere on the premises unless previous authorization is given. No alcoholic beverages, illegal substances or firearms are allowed on the premises at any time.

Precision Resource management must give approval before any photos or video images may be taken inside the facility.

Smoking Policy

Precision Resource is a smoke-free facility. Smoking is only permitted in designated smoking areas. Please dispose of smoking materials in the provided appropriate containers.

Violence and Harassment in the Workplace

Precision Resource is committed to providing a safe and healthy workplace free of harassment, discrimination, and violence. Personal Protection Equipment

Safety Glasses with side shields must be worn at all times in manufacturing and tooling areas by all employees, visitors and contractors.

Additional Permits and Training

Anyone planning to perform Hot Work, Confined Space Entry, work from raised platforms and ladders, on or from Powered Industrial Trucks or lifts, or work on electrical equipment must contact the Engineering or Maintenance Manager before starting.

Hazardous Material Communication

All chemical used at Precision Resource must have Safety Data Sheets (SDS) on file. All SDS are kept on file in our electronic database. Anyone may request a copy of a SDS from their Precision Resource contact. No chemical shall be introduced to this facility or anywhere on the premises without prior approval from an authorized Precision Resource employee. A list of all chemicals and substances to be used in the building or anywhere on the premises and SDS for each item must be provided to an authorized Precision Resource employee and reviewed by the EHS Coordinator before the commencement of any work or activity.

Disposal of Used Material

Any material that is intended to be left at Precision Resource must be properly disposed. Contact the Maintenance Dept. or the EHS Coordinator for instructions. Our facility has several waste and recycling streams available for disposal.

Health and Safety Policy
