

Notice to individuals under Article 13 of the General Data Protection Regulation (GDPR) concerning the processing of personal data in the video surveillance data record and Article 76 of the Personal Data Protection Act (ZVOP-2)

Precision Resource Slovenia has introduced video monitoring within the facility for the purposes described in this notice. This notice provides you with certain information regarding your rights in connection with such monitoring under the GDPR and Data Privacy Act (ZVOP-2)

Data Subject

Persons entering or exiting the facility whose image is captured through video monitoring.

Purpose of the processing of personal data

- Ensuring supervision, security and control of entry into and exit from the business premises to ensure the safety and protection of people and property and information located or stored in the premises,
- the types of personal data processed for this purpose: picture, date and time of recording.

Legal basis for the processing of personal data

- establishment and management of video collections: Article 76.,77, and 78 of the Personal Data Protection Act (ZVOP-2),
- data retention period: Article 76 of the Personal Data Protection Act (ZVOP-2),
- internal regulations: Company resolution and Video surveillance Act **Users or categories of users of personal information:**
- Employees of the Database Manager who need to have access to the information in order to serve the purpose described above
- Other users might include users who have a basis for obtaining personal data in law (such as a court order), users with whom we have a contractual obligation (such as a service company) which will include an obligation to maintain confidentiality of the data, or users who have the personal consent of the data subject.

Information on transfers of personal data to a third country or an international organization

- Personal data are not carried out to third countries or international organizations.

Retention period of personal data

- 30 days

Information on the existence of individual rights

- With regard to the processing of personal data, the data subject has the right to rectification, the right to erasure (the "right to be forgotten"), the right to restrict processing, the right to data portability, the right to object and the right to lodge a complaint concerning the processing of personal data.
